Funds allocated this year are not used as they don't have enough personnel. Simon mentioned as the personnel are hired by the government, the recruitment process will take at least half a year.

Jenny and Magnus have enquired as to why a number of members group the IT group have resigned and an evaluation would be beneficial for some insight.

3.1. The future status of "Allhuset"

- 3.1.1. The university has started a process to evaluate its lease of the building Allhuset. SU currently rents this building from the landlord Akademiska hus (AH). Currently the building is underutilized. The university want to explore all possibilities for the future of the building including renovating it or not renting it at all. The evaluation process will continue during this academic year. Students are invited by AH to be involved in further discussions in the autumn. CSR would like the faculty councils to discuss this at their next meeting to gain feedback to be discussed at the next CSR meeting.
