In HFR the chair will end her mandate by the summer and currently no one has signaled that they want to take over the position. There have been discussions about a buddy-system for master students. This will aim to help students with the transition to master student.

SFR has discussed hybrid forms of education in the aftermath of the pandemic.

Elis reports that changes to the grading scale for dissertations are being discussed at the Faculty of Science. The members of CSR wanted to know more and expressed a concern that this might be an obstacle to internationalization.

2.3. Stockholm University Student Union, SUS

The election for the representative assembly has taken place and the union is very happy with the amount of people that voted which is the highest percentual number in almost 40 years. A new board, president and vice president, will start their term of office on the 1/7.

Application forms for representation fees for representatives within CSR will be sent out in the following week.


