### 2. Reports

2.1. SUS Kansli and Presidium

A report from SUS presidium has been sent out to everyone. A short summarize of what was brought up in the report is; the budget for the

university was decided on, SU has released a new online course for student representatives, opening hours for the university have, with some minor changes, gone back to how they were before the pandemic, how the student health service will have on campus meeting from next year (right now is only on line) and three of the teacher departments will become one department.

SUS office reported that three networks have started, one for chairs in student council, one for chairs in PhD student council and one for representatives in local RALV groups. The plan is to have two meetings in each network per semester. Information about the representation fee for attended meetings in CSR will be sent out to all the elected members from faculty's councils in January.


