## 3. Discussions

### 3.1 The effects of the Corona pandemic on the university

Elis opens up for a discussion about how Covid-19 has affected students at the university. Sofia shares some information about how the university is currently working with questions surrounding the effects of the pandemic. The university has decided that exams shall not be carried out on campus, the exemption being in some individual cases but then for a maximum of eight students. Sofia asks for input on issues that she can raise at the university board meetings.

Mathilda: It has been a change in how the institutions communicate with the students during the last term. During the spring term the institutions interacted more with the student and it seemed like they really cared about how the student were feeling. Does not feel like it is as important anymore. It takes longer to get technical help and it no longer feels like the university cares as much about the students' health. Feels like a change of attitude in the institutions. Another question that has arisen in the council is that the library has started with the delay fees again. This is problematic since the students are asked not to be at campus anymore which leads to a bigger risk for delays in returning books. This spring the fee was removed and the council wants it to be removed until the students can be at campus again.

Karin: The exams that are now carried out from home does not show the knowledge of the student as well as exams carried out on campus. Have SU discussed about moving to a uniform form of examination so that the exams aren't as uneven as they are now.

Sofia informs of SU's work to improve legal certainty in regards to the exams being carried out from home. It is a problem that legal certainty cannot be guaranteed, as SU is aware of. The university lawyers have as a part in this communicated that it is okay for teachers to require that the student have camera on during an exam. Students that does not have a compute with a camera can do the exam in one of the university's computer halls.

Veronica: Students feel like there is harder now to get in contact with teacher in between lectures if one requires help before an exam or with an assignment.

Sofia informs about how this is something that many students has raised as a problem. However, this is often a result of how the work load has increased quite a lot for the teachers during the pandemic.

Ellinor: Students and teachers seems to think that the semester has worked relatively well. However, students feel that there is a problems whit the fact that some teachers send out pre-recorded lectures instead of having the lecture over video. The result is that there is no opportunity for interaction between the teacher and students. Linjerådet would like it to be stated that there must be a forum for interaction between teachers and students.

Sofia informs that this is a problem that exists in other faculties as well. This is problematic since pre-recorded lectures cannot be seen as teacher-led time but should be seen as a complement.

### 3.2. The mental health of students

Sofia informs about SUS work in raising the question of student's mental health. The Swedish government are giving the Student health 25 million kronor extra next year. The university has asked for SUS opinion on how this money should be used. SUS urges the university to use this money to employee more resources at the student health.

Mathilda: The teachers is responsible in creating a lot of stress for the student. Uncertainty and the lack of clear schedules creates frustration and stress for the students. It is indefensible that the teachers and institutions make a stressful situation even worse for the students.

Ellinor: Have noticed the same thing as Mathilda. Have also noticed that the student associations play an important role in making sure that the students don't feel as lonely during the pandemic.

Alexander raises the literature group as a good example where student representatives can affect which literature the different courses use and by extension how much the literature cost. This in turn effects the mental health of students as we know that many students feel stressed about the lack of money.

### 3.3. Organizing the teacher education

Sofia informs about the proposal to merge the three different subject didactic institutions into one under the Faculty of Humanities. This is to gather all the institutions that conduct teacher education.


